9. The creation of entire related infrastructure and its future operation and maintenance shall be your responsibility.
10. The provisions of "Approved List of Models and Manufacturers" (ALMM) & its amendment issued by MNRE from time to time shall be applicable.
11. You are requested to submit documents regarding ownership/ legal possession of the land along with NA permission/ deemed NA, RFID details of SPV modules and other details as specified in commissioning request form prior to commissioning of the project.
12. GEDA does not owe any responsibility regarding the performance of the said Solar System.
13. It shall be responsibility of Solar Power Generator (Owner of Project) to ensure taking all other statutory permission as required from the various Government Departments & GEDA will have no responsibility.
